# PRINCIPAL'S REPORT

RICHARD HOEKSEMA

Unless the Lord builds the house, those who build it labor in vain. Unless the Lord watches over the city, the watchman stays awake in vain. (Psalm 127: 1)

As Spring establishes itself and the children begin to count down to summer vacation, it is easy for us to be caught in the doldrums of taking life for granted. Each day follows the previous, and the perceived monotony seems to continue. Yes, we see the natural world around us come to life and perhaps we are out in the yard cultivating some of that new life. Maybe we are even astounded at times. But are we struck by the wonder of it? Do we really see God's providence at work? The theory is there, yes. As we quote from the catechism: Seedtime

and harvest continue, but does it really affect us? If we are honest, the answer is likely 'no.' But here is the amazing part, it is not dependent on our acknowledging God's work...His work continues, usually in spite of us.

This Psalm has the title A song of ascents. Of Solomon. These were songs that were sung as families and tribes made their way up to Jerusalem for Feast Days. It was the memory work of the Old Testament...memory work that taught of the wonder of God's grace to His people. It is also

worthy to note that this is 'Of Solomon.' We know that there was no other king in the history of Israel that superseded Solomon. As such, he had money, power, influence and blessings beyond all other kings. It is to be noted that the king who would be able to do anything begins this Psalm confessing his total dependence on God for all things. There is nothing that can be done without God's intervention. If God is not active in something, that something is vain. It is this very idea that is the basis for James's injunction in James 4:13

- 15 where James charges God's people to say "If the Lord wills" when planning things. He then completes that section (verses 16 and 17) by addressing boasting. The implication is that there is the idea that we can do things of ourselves and our arrogant hearts do not consider God in our activities. This is an interesting injunction, especially in a job where much of my day involves specific planning...a call to consider God in all things rather than default to the opinion that things will happen as expected or planned, or worse, taking success of these plans for granted. May we always consider God and His blessing in all things.

Since our last LINK, construction has turned from addition to renovation. Many of you took the opportunity at some point to do a quick walk-through. Now the noise is closer to the office with renovations of the library wing and office area in full swing. It is great to see things progressing, and the end product is worth some inconvenience for the short-term. This too happens only with God's blessing. The Board hopes to have a bit of an "Open House" for the addition at the May 30<sup>th</sup> membership meeting.

At the meeting we plan to have a table displaying items from a 'time capsule' that was found in the library ceiling. That wing of the school is in full renovations, and when the ceiling tile was removed, a plywood box with two years' worth of mementos. If you were in grade 7 in 1988-89 and in grade 10 in 1992-93, this is from your class. Some interesting articles/pictures are inside. The capsule was marked to be opened in 2020, so it is 4 years late, but, as they say, better late than never.

Also, since our last LINK we had some significant things happen at MCS. Our Grandparents' Open House was very well attended, as was our Good Friday/Easter Concert "He Reigns!" Our 7&8 students enjoyed the annual basketball tournament and some others enjoyed the annual MCS Hosted Chess Tournament. I would like to mention Mrs. Teresa Jongsma who, although no longer living in our community, drives up and organizes the Tournament on Maranatha's behalf. А hearty "Thank you" for this! And, while I'm on the topic of volunteers, we have many who help out in the younger grades (particularly in Kindergarten and Grades 1, but also in other places), "Thank You!" to you as well. MCS is better because of you. And, if you've always been interested in helping out, there is always room for more volunteers!

All of these things are testaments to our Father's grace to us. May He continue to bless us all, children, parents, staff and other supporters. It is in this grace and confidence that we go forward into the final weeks of this school year with confidence.

# EDUCATION COMMITTEE REPORT

A privilege of being on the Education Committee is being able to partake in class visits. It is such a blessing to enter the school and hear praises to our God ringing through the halls, to see the interaction between staff and students where everyone is doing their best to praise the Lord in their work. If you were able to attend the Easter Concert, you were witness to a small part of this when we were blessed with listening to God's covenant children's voices resound as they sang with gusto "And He shall reign forevermore, forevermore."

As you would have read in a recent weekly newsletter, we have added an extra Professional Development Day on Monday, May 6. The PD Day will give opportunity for the staff to dig deeper into the new Math program that begins in September. With a new program comes new ideas, a new

approach to learning, new resources, etc. and having a day dedicated to figuring all of this out will enable staff to use this new program to its full extent and therefore benefit our children's learning.

As we enter this 'last leg' of the school year, everyone's schedule gets busy and there is so much on the school calendar as well. I'm sure some students are already counting down to the exciting aspects of the year end and the activities that they are blessed to partake in. And I am sure there are others who are just counting down to the last day, which they are likely thankful to be a day earlier than originally scheduled for. By ending school one day early, with a half day being on the Thursday, we are, in essence, adding a Professional Activity Day (PA Day) for the staff, since this day is not an extra day off for them, but allows them to get their administrative work complete on

the Friday and focus on doing the great shuffle of classrooms the week after! We have decided to switch things around, the primary division (Grade 1-3) will be in the newly built addition, with Kindergarten right next to them in the current Grade 8 room (or the science room as many of us might remember it as). The junior students (Grade 4-5) will use the rest of the east wing, while the senior students (Grade 6-8) will move across the school to the west wing. Through the excitement, the changes, and the challenges we can be thankful for our staff who are invested in, not only our children's educational wellbeing, but even more so their spiritual wellbeing as was noticed in the song that they sang at the Easter program, "Little one be strong in the power of the Lord…you're covered head to toe. And from your mouth the Lord has made a fountain for His praise."

# TREASURER'S REPORT


MCS continues to struggle with cash flow in the operating budget. To be in a comfortable cash flow situation, we need to have at least one month's worth of cash in the bank, this would be around \$160,000. Over the past few months we have been averaging close to \$0.00 in the bank. We did receive significant donations late last year and early which helped this year tremendously as we were quite far in the red at the time, and we are extremely thankful for those contributions. Expenses over the last month were higher than usual and so we are still not in a comfortable position.

We have now finalized the budget for next year and, yes, fees will be going up due to increased costs across the board. If you find that school fees are becoming unmanageable, please reach out to Harvest and apply to their tuition assistance program. Harvest is there to help you! You do not have to wait until your kids are in school, Harvest will also help you meet your presupport payments.

At the upcoming membership meeting, in addition to the budget, two proposals will be brought to the floor for the membership to vote on. The first is a new fee category which is intended for married couples who are not yet due to pay presupport. We have found that

when two singles get married their "married" fees were higher than the sum of their two single fees. The intention of the new "Married Pre-School" category is to make membership more affordable to newly married IVAN SIKKEMA

couples and hopefully we will see more young married couples signing up as members. The second proposal is a new tiered pre-support structure, where the first year of pre-support is much more affordable, each year the fee increases such that after you have paid the four years of presupport, you would have paid amount an equal total of presupport as in the past. Again, the goal here is to make presupport more affordable for young families and slowly increase the payment as they



become more financially secure and are able to adjust their budgets accordingly. More details to follow on these two proposals in the package for the spring membership meeting. Thank you all for your continued prayers and financial support.

we remind everyone that Harvest Support is available for tuition, but also for pre-support.






































































# KINDERGARTEN LOVES OUR PRINCIPAL!
